1. Call to Order-Pam Klena called the meeting to order at 11:04 AM
2. Approval of Minutes-Courtney Snyder moved to approve the minutes from summer 2025, it was seconded by Fran Shelton. The membership voted yay.
3. Welcome & Introductions-Pam Klena welcomed everyone to our luncheon and recognized the Past Presidents and introduced the Executive Board. Heather Hastings was recognized as the winner of our Commission Competition.
4. Recognition of the Corporate Sponsors-Pam Klena thanked DeMoulin Brothers, Quinlan and Fabish, and Yamaha Corporation of America.
5. Board of Directors Reports-Pam Klena recognized the Board of Directors and encouraged the membership to see their reports accessible via QR Code
6. 2025 WBDI Highlights-
  - a. WBDI has made intentional strides toward preserving and archiving the organization and its members through the formation of the Legacy Planning Committee and through steps taken toward assembling a permanent archive. Through the foundation, money was approved to support archival services which will be assembled at the University of Maryland Special Collection in Performing Arts.
  - b. In 2025, a \$500 monthly stipend was approved for the Executive Secretary. This stipend is in line with other organizations.
  - c. WBDI has created a Policies & Procedures document that is under review.

- d. WBDI has shown growth and connection via national gatherings. Our new and expanded meeting spaces as well as the “sponsor a friend” option are evidence of our growth and efforts to create a welcoming and inclusive community.
- e. WBDI has demonstrated strategic financial stewardship via the approval of the 2025-2026 budget. The addition of our rolling membership model has contributed to a healthy and stable budget allowing the organization to plan responsibly and invest with intention. These decisions ensure that WBDI remains accessible, financially sound, forward-thinking, and responsive to current and future members.

7. 2026 Initiatives-

- a. MJ Robinson spoke about the historical curation initiatives at the University of Maryland. John Davis will serve as the primary contact for the project and Dawn Farmer will chair the effort and provide leadership and oversight.
- b. MJ Robinson thanked the Julia Baumanis and Brittan Braddock for laying the groundwork in the Mentorship Committee and welcomed the new Co-Chairs Jenny Neff and Laura Doebler.
- c. MJ congratulated Amy Bovin (Florida) and Lindsey Bogats (Nebraska) on the formation of their state chapters.
- d. On behalf of Lesley Moffit, MJ Robinson recognized the presenters of this year’s professional development sessions.
- e. Chiyo Trauernicht and Amy Wemhoff spoke about the Summer Conference *Building Foundations*. Highlights include a reading session, keynote speaker Paula Crider, a middle school lab band, the Omaha Zoo, *Jazz on the Green*, and an afternoon at the Art Museum. Registration opens on January 10th.

8. Honoring the Legacy of Gladys Stone Wright- The Past Presidents each presented a white rose in honor of Gladys. Her niece Nickki Kehoe presented a single red rose. Linda Moorehouse gave a tribute to Gladys which was followed by a moment of silence.

9. WBDI Scholarship Awards-Shannon Shaker and Meijun Chen reported that the Board and the WBDI Foundation granted additional scholarships as well as increased scholarship amounts.
